2. The tenders should be in the prescribed form obtainable from the college office on payment of the price noted below.
3. Tenders to be sent to the undersigned before the prescribed due date and time. Tenders not stipulating period of firmness and those with price variation clause and/or subject to prior sale condition are liable to be rejected.
4. Tenders without the prescribed EMD will be rejected. EMD of unsuccessful tenders will be returned as soon as possible after the tenders are settled. EMD of the successful tenderer will be adjusted against the security deposit to be remitted while executing agreement. No interest will be paid for EMD.
5. Tenders will be opened on the appointed day and time in the office of the undersigned in the presence of such of those tenderers or their nominees present at that time.
6. If any tenderer withdraws from his tender before expiry of the period fixed for keeping the rates firm for acceptance, EMD deposited by him will be pre forfeited.
7. The tenderers shall specify in their tender the delivery conditions including time required for the supply of articles.
The prices quoted should be inclusive of all taxes, duties, cesses which are or may become payable by the contractor under existing or future laws or rules of the country of origin/ supply or delivery during the contract period.
8. The undersigned has the right to accept or reject any quotation without assigning any reason thereof. Complaints with items supplied during warranty period should be rectified/replaced to the satisfaction of the college, by the suppliers at their own cost.
9. Payment will be made after successful completion of the work, with satisfactory performance.
10. The work should have a warranty for minimum period of one year.
11. Successful tenderers shall execute an agreement with the officer mentioned, in Indian stamp paper worth Rs 500/- within the specified period with a security deposit equivalent to 5% the contract amount. The SD may be in the form of Fixed Deposit in favor of the manager and the deposit to be made in the State Bank of India
12. If the successful tenderer fails to supply the full items of supply or if he fails to fulfill the contract in full, all or any of the materials not supplied may, at the discretion of the officer, be purchased by means of another tender/quotation at the risk and cost of the contractor.
13. In case any difference or dispute arises in connection with the contract, all legal proceedings relating to the matter shall be instituted in the court within whose jurisdiction and the officer voluntarily resides.
